### **4. Policies and Procedures**

- A one-shoot permit may be purchased for photography in Village Square prior to shooting for a total of  

**\$ 84.75** (\$75.00, plus HST)
- Photography will be permitted in Village Square as long as it doesn't interfere with any existing businesses.
- Photographers who are asked by any of the businesses in Village Square to move to an alternate location in the Square must do so.
- Permits can be purchased from Management Office. In addition to purchasing a permit, a photographer must book a specific shoot date and time, in advance of shooting.
- The permit fee, including the fee for a Season Permit, is not refundable, even in the event of cancellation of a booking or non-use in whole or in part of the permit.
- Village Square is a public access environment and photographer must accommodate pedestrian traffic.
- Consumption of Alcohol on the Village Square premises is strictly prohibited.



## 5. Rules, Waiver of Claims and Indemnity

I agree to comply with the rules and regulations outlined by Village Square management. Failure to do so will result in expulsion from the property. I hereby waive any and all claims, liabilities, obligations, losses, damages, penalties, actions, judgments, suits, claims, costs, expenses and disbursements of any kind or nature whatsoever, against Village Square and its officers, directors, employees, representatives, and agents, arising from, connected with, in consequence of, or in any way related to the grant of a permit or Season Permit or the conduct of a photography shoot or the attendance at Village Square for that purpose, including without limiting the generality of the foregoing, any and all claims relating to physical or mental injury to person or damage to property.

I further agree to indemnify and hold harmless Village Square and its officers, directors, employees, representatives, and agents, from and against any and all claims, liabilities, obligations, losses, damages, penalties, actions, judgments, suits, claims, costs, expenses and disbursements of any kind or nature whatsoever, including legal fees and disbursements, in connection with any dispute, action, suit or claim arising from, connected with, in consequence of, or in any way related to the grant of a permit or Season Permit, the conduct of a photography shoot or the attendance at Village Square for that purpose.
